

In reference to report number 16-1158 for an Assault report from the Hangar, located at 127 Chesterfield Business Parkway, I wish to state the following:

On 03-04-16, I was advised of an Assault reported at the above location on 03-03-16. Upon receiving this report, I responded to the Hangar, where I made contact with the Report Carrott, who I identified myself to as a Chesterfield Detective, and asked to discuss this report.

commended agreed to speak with me concerning this report, and escorted me to the rear kitchen area of the business, where I asked commended to explain to me what he witnessed on the evening of 03-03-16 inside of his business.

Characteristics stated that a male and female patron entered into his business together at approximately 2030 hrs, and had several drinks. Constant stated that the male appeared to have been drinking prior to his arrival, but not the female. Characteristic stated throughout their time inside of his business, the male was very disrespectful, and argumentative with the female, and at one point, Characteristic stated he saw the male slap the female across her chest with the back of his open hand.

Common further stated that the pair remained in his bar after the assault, and continued to argue with the male being the instigator.

Common stated when the couple left, he realized that their bar tab had not been paid, so he went out onto the parking lot and located the couple inside of a particle, where Common stated he saw the male with his hand around the female's neck. Common stated the male saw him standing near, and exited his truck and asked what he wanted, and Common stated he told the male he hadn't paid his tab, and the male stated he'll be back in. Common stated that the male reentered his truck, and Common stated that the male reentered his truck, and common saw the back of the female's head going back and forth, as if the male was banging her head against the passenger door window. Common stated the male did pay his tab by credit card, and at one point made the statement, "Every now and then, you got to keep them in line."

I asked Chimal for a description of the female, and he described her as a very and reported that she was described as being white with dark hair. Chimal also advised me that the male was "bragging" about working for the property and that he should be thanked for his service. Chimal also reiterated that the male was very disrespectful and appeared angry with the female.

behavior, and stated that he was going to call the the to report the male's behavior. No information was provided for the patron.

It should be noted that after Carried provided me with the above assault report; Clarant confirmed that he did not call for police, or advise anyone to call for police.

It should also be noted that I asked Calling to submit a written statement, and Calling stated he was not comfortable with submitting a written statement, but was fine with answering questions about the incident.

In regards to the male and female's vehicles; I asked Character where each vehicle was parked and Character pointed to the first isle north of his bar, and pointed to the second parking space where he said was parked, and then pointed to the seventh parking space where was parked.

I asked Chicken if he ever saw either person inside of his bar before, and he replied no. Chicken advised me that the could also provide a statement, and that she was currently working.

I asked Character if I could speak with harmonic, and he complied.


The the was identified as the Female, who responded to the rear area and reported seeing and hearing the male being very loud and argumentative with the female, whom Female described as sweet, and non-combative. Female stated that the male was loud and would argue at random with the female, and appeared to be "bullying" the female, which lead Female to purposely make contact with the couple and ask how they were doing, in an attempt to stop the male from arguing with the female, and also advised the male that he needed to calm down.

Formula also reported that she witnessed the female crying at one point, and appeared very upset. Formula also stated that the couple appeared to have been drinking prior to their arrival, and advised me that the female informed her that she was a


Frame advised me that the male did carry the female to the bathroom on one occasion due to her having a boot on one foot. But Frame reported later as the couple was leaving; the female walked out first and appeared to be upset, and the male yelled, "If you leave, you'll never see me again." Frame stated the male left behind her, and returned a short while later to pay his tab.

It should be noted that this department was notified of this incident by Monarch Fire Chief Charles Marsonette, who was not present at the Hangar; but was later notified, then contacted this department to investigate. Chief Marsonette also identified

as a Chesterfield Detective, and advised her of this report. Upon hearing this report of her being assaulted at The Hangar; appeared to be in disbelief while pausing for a moment, then asked, "Is this a prank?" then asked if we were acting with the because of current work related issues.

I advised that this was a true assault investigation, in which she was identified as the victim. appeared stunned by the details of this investigation, and denied ever being assaulted by . I asked to replay the previous evening prior to her arrival at the Hangar.

to discuss some work related issues, then decided to go to the Hangar for drinks, and to further their previous discussion. The stated they arrived later in the evening, but she wasn't sure of the time, and stated that she and had several discussions involving work and personal issues that was dealing with, which at times became loud, and argumentative, except when the confided about some personal issues, then she would cry.

It should be noted that when disclosed those personal issues with me, she began to fight back tears.

stated at no point did their arguments and disagreements turn violent, and at no time did sassault her; that night or previously.

described sas a friend of approximately 20 years, and someone she could confide in.

I asked why would someone report her being assaulted, and stated she didn't know, but added the only time she was startled that night was when the bar owner caught she and starts off guard by opening truck door and asking them to pay their bill. I asked to elaborate, and she provided the following statement:

in the passenger seat turned facing the when the passenger side door "flung" opened, which startled her, and the owner was standing there angrily demanding they pay their bill. Stated she and looked at each other, and stated to she thought they paid their bill. Stated that did reenter the bar and paid their tab, and after that, they both left in their vehicles, and met a short while later on the Premium Outlet Mall parking lot for a few minutes to talk before leaving.

I asked if she had been drinking prior to arriving at the Hangar, and while at the Hangar, and she replied yes. I asked for the

drinks and the amount she consumed, and she stated some beers, but couldn't remember how many.

I asked if she felt any pain or soreness when she woke up this morning, and she replied no, and offered to have P.O. Flushing to view her chest and neck area upstairs to show no bruising.

It should be noted that was wearing an oversized pullover shirt that provided a clear view of the area just below her collarbone and her entire neck. No bruising or discoloration was observed.

reiterated that the has never assaulted her; that night or on any other occasion.

I asked that they were friends and describe only. I asked that they were friends and describe only. I asked the if there was any relationship of a romantic nature between them, and she replied no, and stated that the has a family.

I asked the if it was possible for her to have drank so much that she wouldn't remember being assaulted, and she replied no, and re iterated that they may have been loud, and argumentative at times, but she was not assaulted.

I asked if she would submit a written statement, and she declined.

I provided with my business card and asked her to contact me if she had any questions or any additional information.

Upon my return to this department, I contacted the by phone, who was aware of this investigation. I asked the if we could speak in person in regards to this investigation, and he stated that he could meet with me at 0800 hrs on 03-05-16 at this department.

On 03-05-16, And arrived at this department and was escorted to Conference Room #105, where I advised that even though he was not under arrest; I was going to advise him of his Miranda rights. Stated he understood his rights and agreed to waive them, which is indicated by his signed rights waiver form that was later entered into evidence.

In regards to the Hangar on 03-03-16; werified that he and arrived separately at the Hangar to discuss work related issues and had several beers each. The stated at times, would get upset about issues discussed, but denied ever assaulting inside the business or outside. The also verified that the became emotional and began crying while discussing a personal issue with him.

at one point, the became so upset that she walked out of the bar, and stated as she walked out the bar, he told her, "If you're gonna treat me like this; I don't wanna meet you no more."

inside of his truck and talked before the bar owner, who appeared and opened up the passenger side door to his truck, and held up a receipt and advised them to pay their bar tab. The stated he reentered the bar and paid his tab and a patron who was sitting at the bar told him, "Don't worry, we know how to take care of guys like you the ", and then stated, "We know the chief of police." The stated he replied, "It doesn't take a far reach to come up with the chief of Chesterfield name."

I asked why people would report that he was arguing with and physically assaulted her, and could only point out that the bar owner didn't seem to like it when he carried to the bathroom because of the boot on her foot. Stated the bar owner may have thought he was "Showboating."

also advised me that he and were sitting at the bar near a jukebox that was playing, so he didn't understand why they were reported as being loud and argumentative, but stated that their discussions did have some "Intensity" to it.

In regards to the bar patrons; stated that upon their arrival; there were two patrons sitting at the bar and a table that was full. Upon leaving; there were only two patrons sitting at the bar.



On 03-08-16; Chief Marsonette responded to this department and advised of 2 additional witnesses:



Chief Marsonette later provided copies of written statements he received from Carrier, Ferral, Common and Bern, along with a copy of receipt which showed a tab of \$38.24 and a time of 2212 hrs. Chief Marsonette also provided exterior video surveillance footage he seized from Lindell Bank located at 169 Long Rd, which captures a portion of the parking lot where this reported assault took place.

It should be noted that I viewed the surveillance footage which is dark and is negative for evidentiary value, due to the darkness which makes it impossible to determine if which vehicle is captured.

In an attempt to enhance the surveillance footage; Det. Brandt, DSN 223, and I responded to the St. Charles Co. Police Dept. Cyber Crimes Unit, where we made contact with Det. Larry McCain who was advised of this investigation. Det. McCain viewed the surveillance footage and advised that no enhancement could be made. The surveillance footage was later entered into evidence.

Marsonette from Chicago, Compa, Bran and Ferror were later entered into evidence.

On 03-08-16, I left voicemails for Bear and Campa, asking them to contact me.

It should be noted that Yoga, located at 130 Chesterfield Business Parkway was closed. My business card was left inside the door.

On 03-22-16, I spoke with Complete by phone, and asked Complete when he and I can discuss this investigation, and Complete agreed to meet with me at this department on 03-22-16.

On 03-22-16, Combo arrived at this department, where I escorted him to Conference #105 to discuss this case.

common informed me that he and Been are friends, and arrived at the Hangar at approximately 2030 hrs, where they observed a couple who were "making out" one moment, and arguing the next. I asked Ceen to describe "making out", and he described them as being embraced in each other's arms and kissing.

Common stated that the couple left the bar several times for short periods of times, then would reappear, and exhibited the same behavior throughout their time at the bar.

In reference to the nature of the arguments, Common stated that he heard the female tell the male something to the effect of, "I'm leaving you" and "why don't you go back to your wife and kids". And on another occasion, the female got up to leave, and the male grabbed at the back of her top outer clothing in an attempt to stop her, but she continued out of the bar with the male behind her. Common also stated he heard the male tell her, "If you walk out the door, we're over."

and told them, "What the hell you're looking at", and Ban asked him to calm down, an advised that they'll call the police, and also stated that the chief of police lived in his sub division. Contact reported that the male pulled out an ID card and stated that he was a the chief was a friend of his, then held up his cellphone and said call him.

Compared also stated that Break told the male that he was a disgrace to the city, and that the male asked to step outside, which to did not.

Common advised that although he disproved of their behavior; he witnessed no violence between the two, and heard no threats.

I asked Combo if he would submit a written statement, and he stated that he provided one to Chief Marsonette.

A copy of Commu's interview was entered into evidence.

On 03-28-16, I was advised that Brand responded to this department and was interviewed by Det. Brandt. See Det. Brandt's supplement.

Due to the denying being the victim of an assault, and having no evidence to support an assault charge; was not booked in this case. However, this report will be forwarded to the City of Chesterfield Prosecuting Attorney to review.

NARRATIVE

In reference to the original report of an assault, I wish to state the following. On 03/28/2016, I was advised that Min Brown was in the lobby and he needed to give a statement. I responded to the lobby and contacted Brown. I introduced myself and escorted him to an interview room. Brown informed me while walking to the interview room that he had already given his statement to Chief Marsonette. I advised Brown that we have to do our own investigation so that is why we needed him to come in.

I began by obtaining Barre pedigree information. I explained to Barre that I just needed to get his statement about what happened that night at The Hangar Grill. Barre told me about what happened.

I advised Book that I wanted to go back to the beginning. I asked Book who he went to the bar with. He stated Some Compart. I asked if he knew if anyone had talked to Compart yet. He said he believes he already gave a statement. I asked Book if he was friends with Book Claration. He said yes. I asked him if that is how we got his information. He said he thinks so, he is not positive, but he got a call from he thinks the captain or someone at the fire department.

He stated that he and Compose were out looking at rental property that evening. He stated that they had dinner and drinks in the City and then headed to The Hanger Grill for more drinks. When Been and Composerived, the bar was basically empty. He stated that the only other customers in the bar were a male and a female sitting at the bar and the female had some sort of boot or cast on her leg.

I drew a picture of the bar and asked B where everyone was sitting.

Best said the male was sitting at the bar closet to the door and the female was to his right. There were two empty seats and then Break was closest to the female and Companies was to the right of Best . The bar owner

B Climbon and his girlfriend were standing behind the bar just to the right of Common. B stated that there was another female employee but he was not sure where she was at.

stated that he believes they arrived somewhere around 9:00pm, but he is not 100% sure on the time. Been stated that the male and female at the bar were arguing. He said that it was loud enough for him to hear and he said that he is hard of hearing. I asked Been what exactly he heard. He said that he heard the female tell the male, "Why don't you go back to your wife." I asked if he heard what the male said. He said he was not for sure. I asked if he heard any other specific comments. He said no.

Based said that he asked Compared and Classical if they heard what was going on between the two. They both said yes. But said that Classical had told him that the male was a compared or something at down the street.

I asked have if he observed any physical contact between the two. He stated the only thing he observed was when the female stood up and started to leave the male stood up and put his arm out trying to stop her. I asked Bear if he succeeded. He said I guess not because she walked out the door and the male followed her. Bear also said that she was crying a lot.

When the male and female left the business, Character girlfriend told Character that they did not pay their bill. Brass said that Character went out to stop them.

I asked Bor if he personally observed anything that happened outside. He said no, and started to tell me what he had heard happened. I advised Bor that I only wanted to know what he personally saw and heard. He said that he did not observe anything that happened outside.

I asked B how long he believes C was outside. He said maybe 4-5 minutes, he was not for sure. I asked who came back in first. He said again he was not for sure but he believes it was the male.

Base said that the male came back in and threw his credit card on the bar. Base said that he stood up and the male asked him if he had a problem. Base said that he told the male that he is friends with the Police Chief and he doesn't think the Police Chief would like the way that he is representing Chesterfield. The male replied, back "Well I'm friend's with the Chief too so why don't you go ahead and call him."

Bres stated that the male retrieved his credit card and left.

I recapped that B never saw any physical confrontation between the male and female that night inside or outside of the bar other than when the male stuck out his arm trying to stop the female from leaving. He stated that was correct.

Best stated that he doesn't want to get anyone in trouble. He said that he did not even want to get involved but Chief Marsonette contacted him asking him for a statement. Best said, "I didn't want to get involved, if this guy is a great dude and what if this guy was just having a bad day, he shouldn't get in trouble."

I asked Been if he would be willing to make a written statement. He stated that he doesn't write well and said that he could send me a copy of the statement that he already provided Chief Marsonette. He said that I wouldn't be able to read it if he wrote it out. I advised him that would be fine. I told him to make sure he signed it and I provided him with my email address and asked him to send it to me today. He said that he would. I thanked Been for his time and escorted him out.
