On today's date	, I received a rad	io call at	in
reference to th	e homeowner named	Ryan, asking to ha	ve a female subject
removed. I was	assisted on this	call by Officer Je	enna Christian, DSN

On my arrival, I was met in front of the home by the suspect, Ryan Leeman, DOB (Million), who gave me the following information.

Leeman said his girlfriend identified as Christian Duvall, DOB (Million), was inside of his parent's house and he wanted her removed.

Leeman said his parents were on vacation, and Duvall did not reside at the home.

When I looked at Leeman, I observed his right and left eye both had fresh bruises. I asked Leeman if his girlfriend assaulted him and he said no. I asked Leeman how he received the bruises and he said Duvall struck him in the eyes in an attempt to revive him after he injected Heroin into his veins. Leeman said he and Duvall were in his home and after he shot up, he passed out and Duvall became concerned about Leeman's welfare. Leeman said when he did not respond to Duvall physically attempting to revive him, Duvall used ice cold water and frozen vegetables from the home freezer to revive Leeman.

Leeman said he and Duvall later started talking about moving into an apartment together in the South County area, when he became highly agitated. Leeman said he had to leave the room because he was extremely upset with Duvall, and was afraid the conversation would lead to a physical altercation. Leeman said when he left the room, he contacted the Chesterfield Police Department to have Duvall removed.

After speaking with Leeman, myself and Officer Christian went to Leeman's condominium to contact Duvall in reference to this incident. When we entered the condo, Duvall was in the lower level living area packing her bags to leave. Duvall appeared to be very hyper and a strong odor of an intoxicating beverage was coming from her breath. While Officer Christian and I spoke to Duvall, she stated she did not know why Leeman

wanted her out, but she was trying to get all of her belongings together in order to leave. Duvall said she had someone coming to pick her up, but her ride would not arrive until 8:00 AM.

Officer Christian and I asked Duvall what happened between her and Leeman during the evening that led to Leeman wanting her out of his home. Duvall said Leeman and her were partying and both had used Heroin. Duvall said after Leeman shot up, he passed out and she was concerned for his safety because he was unresponsive.

Duvall said she physically slapped Leeman in his upper face area, and when he did not respond, she got ice water and frozen food from the freezer to try to get him to respond. Duvall said after she used the frozen goods and ice water, Leeman came to and became extremely agitated and belligerent. Duvall said she did not know exactly why Leeman wanted her out, but said he got worked up over nothing and started to freak out.

While Officer Christian and I spoke to Duvall, I observed a tan steel lockbox sitting on a coffee table in the area in the lower living area. Officer Christian asked Duvall where her "drug kit" was and Duvall pointed at the tan steel lockbox. The tan steel lockbox contained all of the paraphernalia listed above, and included the syringe used to inject Leeman with the Heroin. The steel lockbox and contents were seized by me as evidence for this incident. The evidence seized will be entered by me into the Chesterfield evidence locker using the Evidence Tracker System.

While we spoke with Duvall, Officer Christian and I asked her if anything else unlawful or unusual was going on between her and Leeman. The situation appeared as though Duvall may have been present and providing sexual services to Leeman, but Duvall said no. When we asked Duvall if Leeman was providing cash for drugs or sex to her, Duvall said no.

I contacted Lt. Dan Dunn, DSN 5196, of the Chesterfield Police Department and advised him of the circumstances surrounding this situation. Lt. Dunn approved the arrest of Duvall and Leeman for the Possession of Drug Paraphernalia charges related to their admission to using Heroin during the night in question.

Officer Christian arrested Duvall, properly handcuffed her behind her back, checked for proper fit and double locked the handcuffs. Officer Christian took Duvall to Car 13 for transport to the Chesterfield Police Department. PO Christian checked the rear compartment of Car 13 before and after transport to the Chesterfield Police Department for weapons/contraband and none were located.

I arrested Leeman, properly handcuffed him behind his back, checked for proper fit and double locked the handcuffs. I took Leeman to Car 11 for transport to the Chesterfield Police Department. I checked the rear compartment of Car 11 before and after transport to the Chesterfield Police Department for weapons/contraband and none were located.

Officer Christian arrived at the police department before me and began the booking process on Duvall for the charge of Possession of Drug Paraphernalia. Before the booking process was completed for Duvall, information was developed that Duvall provided sexual intercourse for cash to the suspect, Leeman. Therefore, Duvall was also booked for the charge of Prostitution.

A court date of 10/20/2015 at 7:00 PM was set in the Chesterfield Municipal Court for the respective charges and summons numbers 23049 and 25066 were issued, respectively. Duvall was later placed in cell #7 awaiting the posting of a \$250 cash bond.

When I arrived at the Chesterfield Police Department, I took the suspect, Leeman, to the Chesterfield holdover interview room to conduct an interview. When I spoke with Leeman about his relationship with Duvall, he eventually admitted that he met Duvall through her Backpage advertisement where she was soliciting for prostitution. Leeman said he met Duvall through her Backpage advertisement in May of 2015, and has been using her services since then. Leeman said her ad on Backpage promoted her services as follows:

1/2 hour - \$100 1 hour - \$150 dinner and a date or all-niter - \$300 to \$500

Leeman said the advertisement was still on Backpage, and could be accessed by looking for the name "Christian" in the Escort/Adult Entertainment section.

It should be noted a Google check of Backpage.com showed an advertisement for Duvall under the Adult Entertainment/Escort section. A copy of the advertisement was printed out and seized as evidence by me, and will be entered into the Chesterfield evidence locker using the Evidence Tracker System.

While I spoke with Leeman, he said he and Duvall had developed a somewhat friendly relationship over the past three months, but he was still paying for her sexual services. Leeman said he told Duvall approximately three weeks ago that his mother and stepfather were going on vacation, and he knew she was having problems with a living/working location. Leeman

said he offered to have Duvall live at his home while his parents were on vacation.

Leeman said Duvall has been at his home since the 15th of August, and during that time he has paid her for sexual intercourse even though she was staying with him. Leeman said Duvall has only been charging him half price for her services while she has been at his house. Leeman said the last time he paid Duvall for sex was on Friday night, 08/21/2015, when he gave her \$50 for sexual intercourse.

During my interview with Leeman, he was read his rights, per Miranda using Chesterfield form CPD-39A. Leeman initialed and signed off on the form indicating he understood his rights and he voluntarily gave me a verbal and written statement about his paying for sexual intercourse with Duvall and the circumstances surrounding his drug use during the night of 08/22/2015 into 08/23/2015. The Waiver of Rights form and voluntary statement form were seized by me as evidence in this incident, and will be entered into the Chesterfield evidence locker using the Evidence Tracker System.

While I conducted my interview with Leeman, he was concerned that Duvall may have left additional drugs at his home before she was arrested. Leeman gave written permission for PO Steve Aspinall, DSN 5210, to go into his home and search for illegal narcotics. PO Aspinall responded to 13493 Coliseum, and when he searched for the illegal drugs none were located. Chesterfield Form CPD-52A, a Consent to Search, was completed before this search was conducted.

After my interview with Leeman, I took him to the Chesterfield booking area where he was properly booked and processed for the charges of Possession of Drug Paraphernalia and Patronizing Prostitution, and a court date of 10/20/2015 was assigned at 7:00 PM in the Chesterfield Municipal Court. Chesterfield summons numbers 23050 and 25067 were issued, respectively, for the above charges. Leeman was later placed in cell #3 and he posted a \$250 cash bond before he was released.

I attempted to conduct an interview with Christian Duvall, but she said she had no information relative to the charges that would be of assistance to me. Duvall admitted that she has been a multiple drug user for the past six years, with Heroin being her drug of choice. Duvall said she also uses Methamphetamine, Crack, Marijuana, alcohol and any other drugs which are provided to her for free by her customers. Duvall admitted she pays for her drug addiction while working as a prostitute.

All seized evidence from this incident will be entered by me into the Chesterfield evidence locker, using the Evidence Tracker System.

A copy of this report will be forwarded to the Chesterfield Municipal Court.

There is no further information to report at this time. Any further information will follow in the form of a supplemental report.


