On July 4, 2016, at 0330 hours, I responded to 21 Huntleigh Woods in reference to an assault. Upon arrival, Corporal Mike Murray had already made contact with the caller, identified as:

THOMAS, ZINIA

W/F 21 HUNTLEIGH WOODS HUNTLEIGH, MO 63131

Thomas was in the road in front of the residence and was crying. Thomas advised she had run out of a back door of the residence. Corporal Murray stayed with Thomas and Sgt. Barnett and I walked up to the residence to contact her husband, identified as:

AGNIHOTRI, VIVEK

W/M 21 HUNTLEIGH WOODS HUNTLEIGH, MO 63131

We were able to make contact with Agnihotri at the rear of the residence. Agnihotri smelled of an intoxicating beverage, but advised he had not had anything to drink in a couple of hours. Agnihotri stated that he and his wife have recently been having marital problems because they have

grown apart. Agnihotri said they have been verbally arguing for the past couple hours. Agnihotri stated that they had pushed each other when they first started arguing, but there had been no further physical contact.

Thomas' statement was then obtained by Corporal Murray and Sergeant Thomas advised that she was sitting at her computer doing research when Agnihotri came up to her and began asking her questions. Agnihotri then told her to stop doing research and get a massage from Thomas advised Agnihotri that she did not want a massage from him, and he slapped her in the face with an open hand approximately fifteen Agnihotri then scratched her face while trying to grab her tongue and threw her onto the couch. Agnihotri then got on top of Thomas and started slapping her some more. Thomas stated that he then obtained a toy rubber band gun from another room and began rubbing it on her body in a sexual way. He then pushed her down, causing her hair clip to break, and pulled out chunks of her hair. Thomas said Agnihotri then followed her into the master bathroom, obtained a golf club, and then struck her repeatedly across her arms. He then threatened to drown her in the bathtub and when she was able to temporarily reason with him, she ran out the back door and called this department. Thomas completed a written The written statement, along with the golf club used in the assault, were seized and later placed into evidence.

Corporal Murray observed and photographed Thomas' injuries. Thomas had visible injuries to her right cheek and bruising on her left arm. Those photographs were seized and later placed into evidence.

As a result of this investigation, Agnihotri was placed under arrest for Domestic Assault 2nd Degree. He was transported without incident to the Frontenac Police Station. Agnihotri was read his rights per Miranda, which he stated he understood and refused to make a statement.

A copy of this report will be forwarded to the St. Louis County Prosecuting Attorney's office for their prosecution consideration.
