# OH CANADA! TIM HORTON'S COMING TO TOWN AND COUNTRY... REVISED PLANS SUBMITTED FOR CLAYTON AND BALLAS ROAD:

Several months ago we showed readers plans for a commercial development on the northeast corner of Clayton Road and Ballas Road. Those plans have changed significantly and new plans for a bank, a coffee shop and offices have been submitted to the Town and Country planning offices and are on the agenda for the April Planning and Zoning meeting.











According to the St. Louis Business Journal the coffee shop will be Tim Horton's the popular coffee/donut and sandwich chain north of the border. The bank will be Reliance Bank.

The plans have been submitted by Clayton and Ballas Property, LLC headed by Christopher Pelligreen, who is associated with the bulk oil and pipeline company Omega Partners III at 540 Maryville Center. Pelligreen lives in Des Peres.

# CHILD ABUSE CHARGES DROPPED AGAINST CHESTERFIELD

**DOCTOR:** On February 11, 2015, the St. Louis County Prosecuting Attorney's Office quietly dropped the two felony and one misdemeanor child abuse charges against Dr. Carrie Morrison.





Morrison, who lives on Sugarberry Court in western Chesterfield, is the head of breast imaging and mammography at St. Luke's Hospital. Originally the charges against the 53-year-old Morrison were filed in October after her teenage daughter sought treatment for head and upper torso injuries and the police were notified. The teenager also had photos of her with two black eyes that she reported her mother caused in March.

It was a bit of surprise to see the charges dropped as the prosecutor's office originally fought Morrison's bond reduction from \$40,000 to \$5,000.

Here are the original complaints in the case that we originally posted in October laying out the facts in the case

I, <u>Carrie Brandt, DSN 0223, Chesterfield Police Department,</u> knowing that false statements on this form are punishable by law, state that the facts contained herein are true. I have probable cause to believe that on September 23, 2014, at 17700 Sugarberry Ct., Carrie Morrison, White, Female, DOB 04/16/1961, 5'07", 116lbs, committed one or more criminal offense(s).

Count: 01 ABUSE OR NEGLECT OF A CHILD - CLASS C FELONY

Count: 02 ABUSE OR NEGLECT OF A CHILD - CLASS C FELONY

Count: 03 ASSAULT IN THE THIRD DEGREE - CLASS A MISDEMEANOR

The facts supporting this belief are as follows: On 9/24/2014, the victim, a minor, was hospitalized for bruising and swelling about her head and torso. The victim stated that the injuries were caused by her mother pushing her down a flight of stairs and beating her about the face and body. The victim later provided photos of injuries, specifically two black eyes, resulting from a March 2014 incident, and stated that her mother caused those injuries as well.

### BOARD OF ALDERMAN CANDIDATE HAS A TOUGH TIME MAKING

**MEETINGS:** A check of the attendance record of Tim Walsh after he became a regular member of the Town and Country Board of Adjustment showed that he has not been that serious about serving the city.

From 2012 through 2014 up to when he resigned to run for alderman Walsh had missed 40-percent of the hearing dates for the Board of Adjustment.

Tiffany Frautschi was in the Mason Oaks subdivision on Saturday February 28 knocking on doors along with her campaign manager, Lindsey Butler, who lives in the the subdivision. While standing on the door step at a house in the 13300 block of Cross Land, they both smelled the strong odor of natural gas. No one answered the door, so they called 9-1-1. Here is the description of the event from the the Town and Country Police:

Tiffany Frautschi was knocking on a door in the 13300 Block of Cross Land Drive on Feb. 28<sup>th</sup> at approximately 1140 hours when she smelled a strong odor of natural gas. Police and fire responded. No one was home at the residence but a neighbor had a key. Interior of the house was fine and it was determined that the gas leak was at the meter which was on the exterior of the home. Fire remained on the scene awaiting Laclede Gas.


**RESIDENT STOPS HIT AND RUN DRIVER LONG ENOUGH FOR POLICE TO MAKE AN ARREST**: On Thursday February 26 at about 8:10 pm a resident of Mason Oaks Subdivision (the subdivision consists of two streets, Kings Glen and Cross Land) came upon an accident where 25-year-old Lauren Musgrove of St. Ann driving a blue 2002 Ford Taurus had crashed head on into a parked car on Kings Glen.

The resident stopped to see if the driver was injured, however she drove off with her lights off. The resident managed to stop her and try to convince her to wait for the police. She decided not to. The resident called the police back and Musgrove was stopped on Clayton Road at Dry Ridge and arrested for Hit and Run and DWI.

The following is from the Traffic Accident/Crash report. We will have more details about this when we can obtain the DWI offense and arrest report once the case is adjudicated in Municipal Court. I have a feeling this will be an entertaining story.



DRIVER 1 WAS TRAVELING EASTBOUND ON KINGS GLEN DRIVE. VEHICLE 1 CROSSED THE CENTER OF THE ROAD AND STRUCK THE FRONT OF VEHICLE 2, WHICH WAS PARKED AND UNOCCUPIED.

WITNESS 1 STATED HE ARRIVED ON SCENE TO FIND VEHICLE 1 CRASHED INTO VEHICLE 2. HE TURNED HIS VEHICLE AROUND TO CHECK FOR INJURIES, AND VEHICLE 1 WAS DRIVING AWAY FROM THE SCENE WITH HER HEADLIGHTS OFF.

MAYOR AND CITY HALL STAFF GREATLY OUT NUMBER RESIDENTS AT THE "COFFEE WITH THE MAYOR" On Friday February 27 Mayor/Cigarette Lobbyist Jon Dalton held his first hour long "Coffee with the Mayor" at the Longview Park "extra long double wide" extension to the farmhouse.

We understand the residents, all from Ward-2, were outnumbered by staff 9-to-4. Apparently Mayor Dalton is not capable of meeting with residents alone and needs substantial backup.

Present representing the city were Dalton, City Administrator Gary Hoelzer, Police Chief Pat Kranz, Finance Director Betty Cotner, Public Works and Planning Director Craig Wilde, Parks Director Anne Nixon, Parks Administrative Assistant Lindsey Hodge, Alderman Skip Mange and Planner Melanie Rippetoe.

It got worse when one resident left to take a child to elementary school, leaving 3-city employees per resident. The only unit head not there was Municipal Court Clerk Sharon Orlando.

FOOTBALL LIGHTS ARE BACK ON TABLE: Rumors have Christian High School ready to come back for lights on the football field. When Westminster Christian Academy moved to the former 68.8 arce West County Technical High School campus in 2008, they reluctantly agreed to to have no lights on their football field. But said they didn't like it and would be putting football lights back on the table before Planning and Zoning and the Board of Aldermen. That issue appears to be coming back!

Currently there are rumors at city hall, with politicians and in neighborhoods that Westminster will be back this year after the local elections wanting the lights for the fall football season. For new residents or new readers here is the story from 2008:



# HERE IS WHAT I WROTE ABOUT THE FIRST PLANNING AND ZONING MEETING ON THE WESTMINSTER FOOTBALL LIGHTS, BACK WHEN I WAS ON THE BOARD OF ALDERMEN NI 2008:

THE WESTMINSTER CHRISTIAN ACADEMY STADIUM AND LIGHTS: The June 25<sup>th</sup> Planning and Zoning meeting was all about the request to rezone the property on Maryville Drive on the south side Highway 40 to a major educational campus. Also on the agenda was the request for approval of site development changes that would include a football stadium with lights on 68.8 acres. Finally the third item on the agenda was a request for a conditional use permit for a 2,000 seat permanent football stadium with lights. By the end of the night none of these items were voted on and all were continued to the July 16<sup>th</sup> meeting.

The place was packed. There was no where to park on the parking lot and only about three empty seats. It looked like a municipal court night, but the crowd was much better dressed than what you'd see at Muni Court.

The evening started with the WCA presentation. It contained the history and growth of the school, now located at the old Ladue middle school site on Ladue Road in Creve Coeur west of Spoede Road, to the character and values of the school and staff...This was the yada, yada or etc, etc. part of the meeting, since no one questions WCA's academic standards.

The stuff people wanted to hear dealt with lights, noise and traffic. Brandon Harp, a profession engineer for WCA, put on a show that included the site layout and purported site lines from residences on Brook Mill and Arlington Oaks to what appeared to be the corner of the press box of the proposed football stadium.

Frankly the site layout looked more like a Soviet Olympic sports training facility than an American high school. The site plan had the school building which includes a gym, plus a huge free standing athletic center located behind the school that contains among other things, a hockey rink. In the area abutting the Savvis and Kellwood commercial properties were a baseball field and softball field. Closer to the west side of the school were tennis courts and a lacrosse field. On the east side of the property was the football stadium with a track and further to the west was an extra soccer field, since they planned to use the stadium field for both football and soccer.

Mr. Harp showed line of sights photos taken in the middle of summer with trees' leafs blocking views, but he did not offer any photos taken in the fall or early spring when the trees had no leafs. His measurements of distances from houses to the football stadium were slanted to favor WCA. The measurement went to the far west edge of the stadium and not the area nearest to the houses. During the presentation folks for WCA let slip another use they had planned for the football/soccer stadium besides athletic games. They plan to hold Praise meetings & concerts and other religious events. Here is a new concern for neighbors. When I covered minor league baseball in Maryland,

occasionally a church group would rent the stadium for a Christian Music concert after the game and would invite the fans to stay for the concert. Once I remember commenting to another sportswriter, "Oh good I can listen to Christmas Carols while I'm writing my game story." But no I found that "Christian Music" was some of the blandest almost white noise I have ever heard. There doesn't seem to have been a Rodgers and Hart or Jerome Kern or Cole Porter in the Christian music writers group. WCA sent current students, former students and student's parents to speak at the public hearing.

They all spoke about what a great school WCA is but none of them talked about lumens or decibels. Former Cardinal Baseball players with kids going to WCA were in the crowd.

From about 8:30 to 10:10 pm the public went to the microphone and spoke. There were only two people associated with WCA who actually lived in the area of the school. One sang the praises of the school and exclaimed what a great neighbor it would make. The other sang the praises of the school and said what a miserable neighbor it would make if they had nighttime football and a lighted sports stadium. 15 people who would be impacted by the site development spoke of having concerns and some asked by the football stadium could not be moved to the commercial area by Savvis. Meanwhile eight T&C residents who would not be impacted by the site changes, but had a vested interest in WCA such as having children attend the school or being employees of the school spoke simply to the excellent education WCA provides.

One of the reasons WCA wanted the football stadium on the east side of the property was so the football field could run north and south and so the setting sun would not be in players eyes. To hell with the right fielders on the baseball field! Commissioner Harvey Schneider asked if they worried about the sun, why did they need lights? He was told September games would start with the setting sun in the western sky. However if you moved the football to replace the baseball field and put it on a NW to SW line...you could still force all the light and noise to the commercial property of Savvis and Kellwood and away from homes and the nursing home.

Mayor Dalton, who does not attend all that many P&Z meetings as a board member, was present. At the end of the evening he made a pretty good request. He asked for WCA to come back to the next P&Z meeting and provide a very good reason and compelling case why they needed to play Friday night football since they have not been playing Friday night football up to this point.

I have to add that there was no way the residents of the Oak Park subdivision would have tolerated night football games in their backyards in Creve Coeur at the present location of WCA.

However what really disappointed me was the fact that no one on P&Z and none of the residents from Brookmill or Arlington Oaks bought up the impact of the proposed location for the football stadium would have on the residents of the Delmar Garden Nursing home and the Garden Villa assisted living.

The average life expectancy at a nursing home is 3 ½ years. Do these folks need to put up with the noise and glare of the lights from this football intruding on their lives? Not one person inquired about sight lines or noise levels for the elderly neighbors. Steve Fons, a Ward 3 alderman told me that the people decided to live in front of Highway 40 so noise should not a problem for them. While the front of their facility is noisy the rear up to this point has been the quiet area on the property.

To me P&Z members and Board of Aldermen have to consider the new residents at the nursing homes a year, two years, ten years later and what impact the noise and lights from a stadium will have for them. This reason alone is a good reason expect to see how WCA at least considered having the stadium next to the commercial property.

**SEPTEMBER 2008 WESTMINSTER WITHDREW REQUEST FOR LIGHTS**: However, while agreeing to the zoning restrictions that called for no lighted football field adjoining subdivisions, a school official said they would be back with the request. WELL, THEY ARE BACK! Here is what we reported on about the Westminster withdrawing the lights request in 2008.

**WESTMINSTER CHRISTIAN ACADEMY**: WCA staff and designers all put on their presentation of what a wonderful school WCA is. They went through the show of the landscaping on the parking lot, traffic studies and traffic flow, changes to the building and athletic fields. They did not go to the area of greatest concern—the football stadium and the lights.

The school cancelled the third scheduled Planning and Zoning meeting, which was to deal with the stadium and the lights. They claimed they were withdrawing the request for lights. But almost everyone knew that after they got approval on the location of the stadium, 350 feet from the Delmar Gardens nursing home and behind both Brook Mill Drive and Arlington Oaks, they would come back requesting lights.

Finally in this hearing they admitted that was exactly what they planned to do. That is my problem: why drag these residents through this again and have the "No Stadium Lights" signs re-appear? Put your wishes and desires on the table now and let's deal with it now. It is as if with a wink and a nod we are ignoring our duty.

Some of the questioning included the head of the school admitting that they fully intend to come back and ask for lights at the proposed stadium. They also stated that building the stadium near the Savvis commercial property away from the nursing home, the two neighborhoods and next to the largest amount of parking spaces, would cost them an additional \$1 million. How much do you want to have lights? The overall project cost is \$66 million. Can a million be saved from somewhere else to allow for the lighted football field next to commercial property?

# MONARCH FIRE DISTRICT CHALLENGER DOESN'T LIKE TO VOTE:

Kelley Denise Miller who is running against Monarch Fire Prevention Board President Robin Harris has a very sad record of involvement in the political process whether on the local or a state level.

Miller who made one appearance at a Monarch meeting and gave a speech that marked her as a clear Firefighter's Union Pawn a month before the filing date for the April election.

In 14 years other than presidential elections Miller has voted exactly two times. She has never voted in an April local or county wide election or in the one Monarch election since she moved into the District in 2012.

She has only voted in one primary election in 14 years.

Robin Harris' voting record includes appearances for local, primary and November elections dating back to 1999. His has missed on some local April elections including those when there were no contested races, but not many of them.

## MONARCH CHALLENGER MILLER SENT ETHICS VIOLATION WARNING LETTER:

On March 3, 2015 Kelley Miller was sent a warning letter from the St. Louis County Board of Elections for failing to file a required "40-Day Before Election" Report, which was due on February 26 with the Missouri Ethics Commission. The report was electronically filed the next day.

The report showed just three contributions totaling \$700, all from people living outside of the outside of the fire district, including two from outside of St. Louis County and one from outside of the State of Missouri. It's interesting that Miller's campaign committee is

named "Taxpayers for Kelley Miller" but no taxpayer has contributed to her campaign yet.



# WE REVIEW ANOTHER FIREFIGHTER'S UNION LAWSUIT:

**PART 1** This week we looked at a complaint filed by Monarch FPD Captain and Local 2665 shop steward Andy Stecko with the Missouri Commission on Human Rights on December 18, 2014. Similar to a lawsuit we reviewed in last week's newsletter Stecko claims the rehiring of Assistant Fire Chief Cary Spiegel has caused a hostile work environment for him, but he does not cite anything that Ast. Chief Spiegel has directed toward him.

# The Stecko complaint claims:

"As a result of the District's recent actions, I have been made to suffer humiliation, anxiety and stress. I fear retaliation at the hands of Mr. Spiegel and the District."

"I am requesting that the District rescind its decision to hire Cary Spiegel and any further retaliatory actions against me, as well as that the District pay my attorney fees and costs related to the bringing of this action, and for such further relief as the commission believes just and necessary under the circumstances of this case."

On the same day the complaint was filed by Rick Berry, who is the lawyer for Local 2665 of the firefighter's union, the Missouri Commission on Human Rights sent a fax back to him with this notation:

"Will accept for filing when adverse acts occur, but not due to threats of discipline and possible termination."

In other words the Human Rights Commission rejected the complaint for having no merit.

Stecko and the union did not like the response of the Human Rights Commission, which claimed something **had to happen** to the employee before they could consider a case.

On January 12, 2015 Attorney Rick Berry on behalf of Stecko sued the Missouri Commission on Human Rights in the Cole County Circuit Court in Jefferson City.

Relator has also filed Suggestions in Support of his Petition for Writ of Mandamus, which is hereby incorporated by reference.

Stecko and the Local 2665 want the Fire District to pay Stecko's attorney fees. Once again it may technically be the Fire District, but in reality Stecko and union want taxpayers to pay for their complaint that was rejected for not having any merit.

Part 2 In April of 2014 Attorney Berry filed a complaint with the Missouri Commission on Human Rights that was similar to the complaint filed in behalf of Stecko. This one was on behalf of four employees, who made similar claims later made by Stecko that they were in fear because Cary Spiegel was rehired as Assistant Fire Chief. On November 20, 2014 the Human Rights Commission notified Berry that the complaint was being terminated due to a lack of jurisdiction because no adverse action been taken toward the employees.

Despite knowing this Berry and Local 2665 decided to waste the taxpayer's money by filing an identical complaint using the same facts in behalf of Stecko.

On December 19, 2014 the day after Berry filed the complaint on behalf of Stecko and had that complaint rejected, Berry filed a lawsuit against the Human Rights Commission for rejecting the complaint filed by the four employees in April.

Once again the firefighter union attorney is filing lawsuits and complaints that he should know will be tossed out by the courts or commissions. Our only guess is that it is being done so the union can claim in campaign mailings there are an excessive number of

lawsuits against the Fire District while Robin Harris has been president, but it is the union that created the lawsuits.

These lawsuits are costing the taxpayers big dollars. First the Fire District has had to defend itself and now State of Missouri lawyers are forced to defend the Human Rights Commission. It seems as if Local 2665 should have to repay the taxpayers for these lawsuits and complaints that are dismissed or rejected.

THE LAST FOLLOW UP ON THE SMITTY'S ASSAULT: This will be the last time we write about the assault on longtime Smitty's Bar and Grill waitress/bartender Nancy Seaman. We reported on January 20th in Newsletter 161 that suspect Jayne Baning on January 16, 2015 pled guilty to the January 2013 assault of Seaman. Baning entered an Alfred Plea admitting there was enough evidence to convict her.





A week earlier a civil lawsuit filed by Seaman against Baning was settled. It involved Baning's homeowner's insurance.

Regular readers know that after telling Baning she would no longer serve her due to her intoxication, Baning took a Martini glass broke it and viciously attacked Seaman, knocking her to the floor and slashing her face with the broken glass. Despite Seaman having life altering injuries the responding Chesterfield police officer, Officer Sharp simply issued Baning a summons for common assault.

I complained to Police Chief Ray Johnson and the case was sent to the County Prosecutor's Office where charges were issued and Baning was later indicted.

After she pled guilty and was given a "No-Record" 5-year probation term I obtained a copy of the police report and later went to Nancy's house for a chat.

Officer Sharp's police report contained the following "she had

gotten into a verbal argument with a Baning over graffiti written on the bathroom wall. The patron denied involvement. Later in the evening, she asked the Baning to leave. After several requests to leave, she came from behind the bar and grabbed the patron by the arms and was escorting her to the door, at which time Baning, the patron, swung at her, still holding the drink in her right hand, striking her to the left side of her face, causing a laceration, at which time they both fell to the floor. The two were pulled apart by Witness Actions and the cook, the Upon separating the two, the patron, Baning, left the restaurant in her vehicle, a dark colored.

Officer Sharp made no attempt to document the graffiti on the bathroom wall either visually or with a photograph. Nancy later told me that after she last used the restroom, the only females in the restaurant were Baning, her and the wife of the owner, Don Schmitt.

The graffiti was "----- is a whore." Nancy told me Baning had written in the name of a 63-year-old popular customer who Baning had a loud and nasty argument with 10 years earlier over facial moisturizers.

The police report also did not include statements from the cook who pulled Baning off of Seaman on the floor as Baning continued to slash at Seaman's face with the broken glass or a detailed statement from Mrs. Don Schmitt.

Then Officer Hernandez wrote a report about how he took photos of the scene. He mention taking a photo of a broken "beer glass" and seizing as evidence a "broken beer glass." Now perhaps Officer Hernandez never gets out and is never around where alcohol being served...but there was no broken "beer glass" used as a weapon. It was a broken cocktail or martini glass that contained Seaman's blood and hair.

A month and a half after the assault and after my complaint to Chief Johnson, Det. Ovca obtained medical records sustaining Seaman's injuries and took a longer statement

from Nancy. It was much more detail than the one taken the night of the assault. Here is part of that statement:

Seaman walked out from the back of the bar and to Baning and as she was trying to take the drink from Baning, Baning said "Fuck you, you can't have it." Seaman could not get the drink from Baning, and Baning threw it in her face. Seaman said the alcohol was burning her eyes, and she could not see. The next thing Seaman knew Baning hit her in the face with the glass on the side of her face and she felt it slice her face open. Seaman said they both went to the floor, and Baning ended up on top of her and continued hitting her. Baning had her legs wrapped around Seaman and Seaman could not get away. Seaman said she was choking on her blood, and ended up throwing it up onto Baning. Seaman said tried breaking it up, but he could not because Baning was still swinging the glass and stabbing Seaman in the face, head and back with it. At this point was and and (last name unknown) came in and helped separate them. Seaman said she pulled out of her shirt to get away from Baning and ran to get a towel for her face. Baning then left the bar.

Det. Ovca's report ended with the following:

Due to the extent of the victim's injuries, this report will be forwarded to the Saint Louis County Prosecuting Attorney's Office for their review.

The Chesterfield Municipal Court was notified and the municipal assault 3rd charge has been dismissed at this time.

**THE CIVIL CASE:** The civil case filed by Seaman against Baning had the insurance company paying the policy limits on Baning's homeowners insurance policy of \$300,000. \$258,000 went to pay worker comp medical bills thanks to the seven operations Seaman had to endure and to her attorney. Nancy got \$42,000.

Nancy still can't work as she occasionally has severe migraine headaches that often last for two hours or longer. While taking to her she will occasionally touch her front teeth. The slashing cut nerves are forced her to have several root canals. She has the sensation that her teeth are falling out.

She has a daughter in college and a son in high school.

THE NEW DRESS SHOP IS OPEN IN THE CHESTERFIELD VALLEY: About six weeks ago I ran a photo of a store front between the Hangar Grill and the Yoga Studio

in the Chesterfield Town Center shopping center on Long Road at Edison Road. The space was being readied for a dress shop.

The shop, Rachel's Grove, is now open.

time...that he refuses to pay his taxes on time. Clearly this guys needs to be dismissed as soon as possible.

There are 26 pages of lawsuits filed by Brockmeyer where he is the plaintiff holding promissory notes.

But the misleading figure given by the DOJ and reported on national news that really got me was how over 90-percent of the Peace Disturbance arrests in Ferguson involve Blacks. Ferguson is 70-percent Black and 30-percent White. This is a town where "white flight" struck a decade ago. Let's face it...a large number of the remaining 30-percent White population are older people and retirees who own their homes outright. These people are not likely to be getting arrested for Peace Disturbance regardless where they live.

Now the Ferguson Municipal Courts and how they fine and issue warrants for lower-income is another story. So is the documentation of the Ferguson cops writing five or more traffic tickets to someone which would result in hundreds of dollars in fines. I'm mean...write one or two tickets and tow the unsafe car off the street. Public Safety has been served. Writing five or more tickets to a person who can't afford to keep their car in safe condition seems counterproductive. If they are busy paying fines to avoid Fail to Appear warrants to stay out of jail then they don't have the money to get their car fixed.

Bruce Kunz writes a column dealing with old cars that appears on Mondays in the Post-Dispatch, usually in the back of the Sports Section. 

**SATURDAY NIGHT**: We had a great time on Saturday night. We went to Nathalie's on 4356 Lindell, just past Taylor. A five piece jazz group was put together featuring Arthur Toney on piano, Randy Bahr on guitar, Joe Weber on drums, Jim Manley on trumpet with Charlie B on vocals. Gene Lynn had been booked for that date with Randy Bahr and Arthur Toney, but it had been known for over a month that Gene was too sick to perform. It turned out he died that morning.

The often half empty bar area was packed on this night and the music went past 11 pm. Gene Lynn had not been mention until the very end of the night when the band played "It's a Wonderful World" in tribute to Gene.
