#### **DRUNKS AND THIEVES 2022 PART 4**

**SUSPECTED ILLEGAL ALIEN FROM GUATEMALA ARRESTED FOR DWI AND OTHER CHARGES**: On Friday night into Saturday July 28, 2019 Chesterfield Police Officer Ashley Saffa was working the midnight shift. At about 1am she was NB on Highway 141 from Ladue Road when she noticed a vehicle (2001 Honda Civic) ahead of her being driven at a high rate of speed. She caught up to the car and paced it at 70 MPH in the 55 MPH zone. She also noticed the driver had trouble staying in one lane.

She pulled the car over just south of Olive Blvd and contacted the driver, Federico C. Martinez, 39, living in St. Charles.

Martinez spoke limited English. It quickly appeared that he had been drinking and was intoxicated.


Martinez at first denied having anything to drink. Upon exiting the car and almost falling down he now said he was "fine" when asked how much he had to drink.

He failed several field sobriety tests and others were not given due to a language barrier. When first contacted Martinez could not produce a drivers' license but DID PRODUCE a Guatemalan Citizen card. Below is the condition that Officer Saffa found Martinez in when she had him exit his car:

Once at the police station a translation service was contacted and assisted in translating questions and responses.

Martinez agreed to take a breath test. The results of the test showed his BAC level to be at .190%.



During booking and during an interview Martinez continually farted.

He denied being drunk. He stated he had been awake for 74 hours and had not had anything to eat and that was why he felt drunk. The problem with this statement is Martinez works as a cook. He admitted having five beers while at work.

Martinez was issued citations for DWI, Improper Lane Use, Speeding, NO Auto Insurance. Attempt to contact ICE were made with no luck concerning Martinez' illegal status.

### GOING 101 MPH ON I-64 AFTER SMOKING MARIJUANA WILL GET YOU NOTICED

**BY THE COPS:** It was just before midnight on Friday February 28, 2020. Chesterfield Police Traffic Officer Todd Lantz noticed a vehicle (2015 Chrysler 200 sedan) in front of him on EB I-64 travelling at a high speed. The Chesterfield Airport was just to the south so the vehicle was not about to take off. Officer Lantz turned on his forward radar and clocked the car at 101 MPH in a 60 MPH zone.

Officer Lantz got the car stopped on I-64 near Boone's Crossing. As soon as he contacted the driver, Cole Mayfield, 23, of Brentwood, he could smell a strong odor of burnt marijuana coming from the car.

Mayfield admitted smoking marijuana in the car before driving. He also admitted that there was glass marijuana smoking pipe, a marijuana grinder with marijuana still in and a .380 caliber Glock pistol in the car.

The marijuana items were seized. Once the check on the gun showed it was not stolen it was locked in the trunk.


Concerning his speeding Mayfield stated he was unaware of how fast he was going until he saw the flashing lights of the police car.

Mayfield had no odor of booze on him or on his breath. He failed several field sobriety tests. This is from Officer Lantz's report:

Mayfield agreed to have a blood draw and was taken to St. Luke's Hospital.

He was then taken to the police station where he was booked and issued citations for DWID and Speeding 101 MPH.

**OUTCOME**: Mayfield hired a lawyer. On April 7, 2021 prosecutor Tim Englemwyer reduced the DWID charge to a Health Code Violation. Mayfield pled guilty to the

offense he did not commit and Judge Rick Brunk fined him \$250. Of course when you are convicted of a Health Code Violation no points go on your driving record.

He also pled guilty to the 101 MPH Speeding charge. He was sentenced to 2-days in jail and a \$410 fine. Did I mentioned that he had hired a lawyer? He was placed on a 2-year SES probation period meaning no jail time or fine, but the points will go on his license and he has to attended two or complete two schools/programs.

DRUNK DRIVER STATED HE WAS COMING HOME FROM A NIGHT OF DRINKING AND FELL ASLEEP ON OLIVE BLVD. HE WOKE UP AFTER HITTING THE MEDIAN CURB AND A TREE. On Thursday morning June 11, 2020 Chesterfield Officers Kyle Tyndell and Travis Layton were dispatched to a single car crash on Olive Blvd. near Appalachian Trail.



On their arrival at the scene they found a 2015 VW Jetta wrapped around a tree in the median of Olive Blvd with extensive front end and undercarriage damage.




Staggering around the car was the driver, Joshua Tyler Moman, 29, of Pacific, MO. Moman appeared to be drunk. He smelled of boozes, had bloodshot eyes, slurred confused speech plus mumbling. He was staggering, swaying and his balance was uncertain.

Moman said he had dropped his cousin off and had been at a bar drinking with friends. He said he fell asleep only to wake up with his car wrapped around a tree.

He basically had already flunked the field sobriety tests before any were give, but Officer Tydell gave them anyway and resulting in a "F" performance. Moman was arrested and taken to the police station.

He agreed to take a breath test that was given about an hour after the crash. The test showed his BAC level to be .146%.



In an interview Moman stated he had been drinking with friends at a bar on Hampton near I-44. He said he had 4 or 5 beers and two hits of marijuana. He also admitted that he thought he was intoxicated.

**OUTCOME**: On 01/21/21 Moman appeared before the most dangerous man in Chesterfield, Judge Rick "If you hire a lawyer you won't be fined or get points" Brunk. Moman hired a lawyer and pled guilty to DWI. Brunk placed him on a SIS "No Fine, No-Points, No Permanent Record" probation. Tim "I rarely ever prosecute anyone if they

hire a lawyer" Engelmeyer reduced the moving violation of losing control and driving off the road smashing into a tree to a Parking Violation with a \$191 fine.

Moman who was a drunk driver high on both booze and marijuana ended up with no Moving Violation and no points on his license.

# CHESTERFIELD POLICE REFUSE TO RELEASE DWI REPORT CLAIMING PROBATION EXPIRED 4 ½-MONTHS AFTER I REQUESTED THE REPORT: On Saturday June 1, 2019 Jessie J. Moehsmer crashed his car on I-64 around Boones Crossing. He was arrested for DWI and possibly companion charges. I learned of it after it was posted on the City of Chesterfield's Crime Reports on the city's website on Monday June 3, 2019. See below:

I regularly check the crime reports and those involving drunk/drug drivers or thieves and burglars, I place the suspect's name on list I check of pending Chesterfield and a separate list of pending Town and Country cases.


In May of 2021 I discovered that the above case had a plea. I found checking casenet that there had been a reduction of a moving violation to Misc. Health Code Violation with a plea of Guilty and a \$225 fine. That is an open record even if the charge is a companion case. I later learned that the DWI charge pled out and there was a SIS probation that expired on September 24, 2021.


On June 4, 2021, Four-and-a-half months before the probation term was to expire I requested a copy of the report. On 10/21/21 I did not receive the report but was told in an email that the probation period is now closed and the report is closed. But I asked for the report on June 4!

I also did not get the crash (accident) report. I had to point out to the City Attorney and with the police record room that the crash report was an open public record. I then got the crash report.

I then learned at 9:38pm on Saturday June 1, 2019 Jesse Moehsmer, 37 of Shawnee, Kansas, drove across three lanes of WB I-64 and then off the road hitting a MoDOT Mileage marker sign and then a sewer grate causing extensive damage to his Nissan 370Z.



There was no mention in that narrative of the crash report that Moehsmer was drunk or was arrest. There was a referral to the DWI report by report number only. The only clue that Moehsmer was DWI was in a check-box section of the crash report reference what caused the crash.



Here is the narrative from the crash report.

MY INVESTIGATION REVEALED THE FOLLOWING: ON 06/01/2019 AT APPROXIMATELY 2120 HOURS, V1 WAS TRAVELING WESTBOUND ON I-64 APPROACHING BOONES CROSSING. V1 WAS TRAVELING AT A HIGH RATE OF SPEED AS RAIN BEGAN TO FALL ONTO THE ROADWAY. V1 BEGAN TO HYDROPLANE AND WENT OFF THE ROADWAY ON THE NORTHSIDE OF THE HIGWAY. V1 STRUCK MODOT MILE MARKER 17.8, RAN OVER A MODOT SEWER GRATE, AND CAME TO A COMPLETE STOP FACING EB ON THE NORTHSIDE OF HIGHWAY I-64. SEE COMPANION REPORT #19-2341 FOR FURTHER INFORMATION.

DRIVER 1 STATED THAT HE WAS TRAVELING NORTHBOUND ON I-64, HYDROPLANED, AND THEN STRUCK THE HIGHWAY MILE MARKER SIGN. AGAIN, D1 WAS ASKED ABOUT HIS DIRECTION OF TRAVEL AND HE THEN STATED THAT HE WAS TRAVELING WESTBOUND.

WITNESS 1 STATED THAT HE WAS TRAVELING WESTBOUND ON I-64 AND OBSERVED V1 TRAVELING AT A HIGH RATE OF SPEED AND WEAVING IN AND OUT OF TRAFFIC. W1 STATED THAT HE OBSERVED V1 HYDROPLANE DUE TO THE HEAVY RAINFALL AND STRIKE THE MILE MARKER SIGN LOCATED ON THE NORTH SIDE OF THE HIGHWAY.

NO INJURIES WERE REPORTED.

V1 WAS TOWED AWAY FROM THE SCENE BY D&L TOWING DUE TO THE DAMAGE.




I filed a complaint with the City Attorney citing that Moehsmer was also cited for Fail to Exercise the Highest Degree of Caution and he pled guilty to a reduce non-traffic charge of a Health Code Violation and he was fined \$225. This should have made the report an open record with only the references to being charged with DWI being redacted. I won...sort of...here is what I got:




On Saturday 06/01/2019, at approximately 2132 hrs, PO Flushing/ DSN 5271, PO Putnam/ DSN 5248, and I were dispatched to westbound IS 64 before Boones Crossing for a yellow sedan which had lost control and went into the ditch with airbag deployment.

Upon arrival, I observed a yellow, 2009 Nissan 370Z, bearing MSL for 2019 off the roadway in the grassy median facing the opposite direction of traffic with a male subject sitting in the front driver seat. As I approached the vehicle the driver, Jesse Moehsmer [ 1982] exited his vehicle and began walking towards me. Moehsmer appeared to be unsteady on his feet. I verified Moehsmer was uninjured and asked him what happened. Moehsmer that a piece of water and I started spinning out. I asked Moehsmer what he hit due to his vehicle having damage and airbag deployment. Moehsmer replied "I hit a bunch of water." Moehsmer advised he was in town from Kansas City for the Blues game.







That was good reading. Another excellent written police report well worth the report fee.

**OUTCOME:** Despite a witness reporting that Moehsmer was driving recklessly at high speeds in rain prior to wrecking his car by running off the road, Chesterfield Prosecutor Tim (If the hire a lawyer give them a deal) Engelmeyer and Judge Rick "Let'm Loose" Brunk saw to it that Moehsmer had no points and no record for his DWI or crash.

HERE IS ANOTHER CASE WHERE A DRUNK DRIVING REPORT WAS DENIED TO US BECAUSE THE PROBATION WAS ENDED A YEAR EARLY DESPITE MY REPORT REQUEST COMING BEFORE THE END OF PROBATION: Brett A. Mudd of Labadie, MO was 31 on Wednesday September 26, 2018 when Chesterfield Police Officer Brendan Steber saw him at 10:23pm driving his Mercedes Benz on Clarkson Road at a high speed.

Officer Steber turned on his moving radar unit and clocked the Mercedes at 69 MPH in the 45 MPH zone. Officer Steber promptly stopped Mudd on Clarkson. He asked him if

he know he was speeding. Mudd said he was aware he was speeding and was going to a friend's house.

I wish I could tell you more. Officer Steber writes very detailed police/arrest reports but I wasn't able to find much out. Mudd was drunk and was arrested for DWI and Speeding. I was able to learn that he took a breath test and the results were .119% BAC meaning he was over the .08 limit. I did not learn this from Officer Steber's arrest report but from Mudd appealing and losing his Drivers' License Suspension with the Department of Revenue for a DOR document.

In late May of 2021 I learned that Mudd pled guilty to DWI on 01/22/20 and was placed on a 2-year SIS probation period. On June 4, 2021 I filed a written request for a copy of the police report. On June 8 Mudd's lawyer was in Chesterfield Municipal Court requesting that the probation period be ended early. His request was granted.

In November of 2021 the Chesterfield Police Department denied my timely request for a police report, saying by the time they were filling my request in October the probation period was over. I appealed pointing out that Mudd was also cited for speeding and that was an open record.

Here is what I received:


#### NARRATIVE

On 09/26/2018 at approximately 2223 hours, I was on patrol in the area of Clarkson Road (Missouri Route 340) and Baxter Road in Chesterfield, Missouri 63017.

I observed a black in color Mercedes-Benz E350 travelling south bound on Clarkson Road after Baxter Road. I observed the Mercedes-Benz to be travelling faster than the traffic around it. I checked my in-car radar system and found the Mercedes-Benz to be travelling at 69 miles per hour in a posted 45 mile per hour speed zone.

I activated my emergency lights and sirens and conducted a traffic stop of the vehicle on Clarkson Road at Bow Tree Court. The vehicle pulled over without incident.

I contacted the vehicle's driver, who identified himself as Brett A.  Mudd. Mudd informed me he was aware he was speeding and stated he was attempting to drive to a friend's residence. Mudd provided me with his Missouri State Driver's License

**DRUNK DRIVER WHO RESISTED ARREST DOESN'T HIRE A LAWYER AND IS SENTENCED TO 7-DAYS IN JAIL**. Anthony S. Morant, 37, was stopped at 8:36 AM on Sunday Morning 09/29/19. He wasn't going to church. The initial reason for the stop on Olive Blvd at Westermill Drive by Officer Devin Kitrel was due to licensing violations and defective equipment on the Lincoln Navigator SUV.

In the old days when you were working the day shift and you pulled over a driver at 8:30 in the morning you were not expecting to be greeted with a heavy smell of booze on the driver's breath. Times have changed.

Officer Kitrel immediately could tell that Morant was drunk. His breath and eyes were the first tip off. Morant began resisting and fighting once Officer Kitrel got him out of the car and more officers responded.

Officer Kitrel handled the Resisting Arrest paper work and Officer Brendan Steber wrote up the DWI.

This is how officers found Morant at the time of his arrest.

When asked after his arrest and after the fighting had subsided Morant was asked if he had been drinking and replied he had been "last night" indicating he was really drunk at some point.

He also gave false names at the beginning of booking but was eventually properly identified.

At the police station he refused to do any sobriety tests and refused to take a breath test. Of course refusing to take a breath test revokes Morant drivers' license, which is apparently no big deal since he has been driving with a suspended or revoked license for over 20 years.

Morant was apparently unfamiliar with the old saying "30 days past September, April, June and November..." because when asked what the date was he said "September 31." He also thought he was either at the St. Charles or St. Louis police departments.

**OUTCOME**: Less than two months after his arrest, Morant dared to appear before Judge Rick "Hire a local lawyer and you'll get off" Brunk without hiring a local lawyer. There was no charge reduction and Mornat pled guilty to DWI, Driving While Revoked, Open Container, and Resisting arrest. He was sentence to seven days in jail.

WOMAN ERUPTS AT DOR OFFICE WHEN DAUGHTER WAITS AN HOUR AND THEN DOES NOT GET HER STATE ID CARD: The Chesterfield Police were called to the Missouri Department of Revenue License Office at 100 Chesterfield Commons East Drive at 6:30PM on Tuesday October 1, 2019 regarding damaged property.

A 15 year-old had come in at 5pm for an ID card. After an hour the card was denied due to address and SSN problems. Apparently mom, Monica S. Mack, was called and was nearby. She came into the office carrying a glass jar. She was upset. When told why the ID application was turned down she threw the glass jar in her hand toward the counter, missing the employee, but hitting, breaking and damaging a computer monitor.

Mack, of Black Birch Drive in Chesterfield, was gone by the time police arrived. The incident was recorded on security video, plus there were two witnesses.

Two days later Mack was contacted and issued a summons for Destruction of Property.

**OUTCOME**: Despite there being video of the incident and the DOR office manager stating he would testified, Chesterfield Prosecutor Tim "I really hate actually prosecuting anyone" Engelmeyer reduced the charge to Peace Disturbance. Mack pled guilty and was fined \$97.

# FIRST THERE IS THE BOMB THREAT, THEN THE COUNTERFEIT MONEY AND FINALLY A COURT ORDER DECLARING HIM MENTALLY INCAPACITATED.

Joseph Michael Longo was being evicted from his apartment in the Village Green complex off of Clayton Road just inside the Chesterfield city limits. The court ordered eviction was issued on March 12, 2019.

Prior to the eviction order Longo went looking for a new residence. One of his stops was on Ground Hogs' Day February 2, 2019 when he went to the Storage Masters storage facility on Chesterfield Airport Road where he contacted an on-duty clerk saying he wanted to rent a unit.



Things got weird from the start when Longo told the rental staffer "not to look at his face." The clerk ignored him. Longo was told he had to be shown the unit that would be rented to him and the clerk took him to the empty unit. That was when Longo said how he was thinking about renting a hotel room, but this might work about better.

Longo then saw a truck that is rented out to customers. He asked to rent the truck that night, but was told it was already rented. He then said if they would not rent him the truck he might put a bomb in his storage unit.

Longo was taken back to the office. The clerk contacted the supervisor then told Longo he would need a second person on the lease. Longo got upset, swore and left the office. The clerk then told his boss about the bomb threat.

Longo returned a few minutes later saying he could give them the name of a second party. The supervisor informed Longo they would not be renting any units to him.

After he left, the police were called.

He was arrested the next day on a traffic stop after seen leaving his apartment. At the police station the arresting officer found \$800 in counterfeit \$100 and \$20 bills in Longo's wallet.

The next day he was still in custody when he was interviewed by a Chesterfield officer and separately by a Secret Service Agent.

He denied ever going to Storage Masters and was then told he was on video being there. Then he admitted he was there.

Longo also denied making the bomb threat. But then changed his answer to "it wasn't like that."

He was cited Peace Disturbance for making the bomb threat and released.

Five months later a St. Louis County Judge ruled that Longo was mentally incapacitated and appointed a guardian.

## JUDGMENT ADJUDICATING INCAPACITATED AND DISABLED PERSON AND AUTHORIZING APPOINTMENT OF GUARDIAN

The Petition for Appointment of a Guardian and Conservator was called, heard and submitted on July 17, 2019. Petitioner Kelly D. Bibb ("Petitioner") appeared in person and by attorney, Paul M. Gantner. Respondent Joseph Michael Longo ("Respondent") appeared by court-appointed attorney, Micah D. Hall. Respondent, by his attorney, Micah D. Hall, waived his right to appear and his right to trial by jury. Pursuant to the agreement of the parties and the Court Order dated July 17, 2019, the interrogatories filed with the Court on July 18, 2019 are received into evidence. The Court FINDS by clear and convincing evidence that:

- 1. Respondent is domiciled in St. Louis County, Missouri and that the Court has jurisdiction.
- 2. Respondent is a totally incapacitated and disabled person by reason of his mental and physical condition and is unable to receive and evaluate information or to communicate decisions to such an extent that he completely lacks the capacity to meet the essential requirements for food, clothing, shelter, safety or other care such that serious physical injury, illness, or disease is likely to occur and that he completely lacks ability to manage financial resources.
- By reason of Respondent's total incapacity, it is necessary to appoint a guardian for Respondent because Respondent's needs may not be met by a less restrictive alternative at this time.
- 4. The Court finds that Respondent retains his right to vote and to operate a motor vehicle.
- The Court finds that Respondent lacks the mental capacity to exercise his right to marry.
- Kelly D. Bibb is suitable and qualified to serve as the guardian of Respondent and authorizes her appointment as guardian.

Respondent is found to be incompetent for purposes of a concealed carry endorsement pursuant to Chapter 571 of the Missouri Revised Statutes.

It is therefore the Order and Judgment of the Court that Kelly D. Bibb is appointed as GUARDIAN for JOSEPH MICHAEL LONGO. Respondent's right to marry is suspended until further Order of this Court. The Guardian shall at all times maintain a valid mailing address in the Court's file. Respondent's attorney, Micah D. Hall, is allowed a reasonable attorney's fee in the sum of \$1,050.00. The Court taxes this fee as costs of this proceeding and orders \$525.00 paid out of funds deposited in the registry of the Court. The remaining \$525.00 shall be paid by Petitioner.

**CHESTERFIELD CASE OUTCOME**: On 12/16/19 Longo pled guilty to Peace Disturbance in Chesterfield Municipal Court and was fined \$152.

SECOND TIME NOT THE CHARM FOR WAL MART EMPLOYEE STEALING: Wal Mart security agents do not just catch thieves coming into the store, but also catch those who are working at the store. That was the case for employee 35-year-old Bobby McCulley.

On April 30, 2020 another employee saw McCulley ring up some purchases and failed to ring up other items. Specifically he stole three rose bushes from the Lawn and Garden Department valued at \$30. The employee alerted security on May 2 about the theft. Security confirmed the theft upon viewing video.

Security employees then went back and viewed other times McCulley was using the self checked out and found that on April 2 McCulley made some purchases before going

home at the end of his shift. He rang up all the items except three boxes of Huggies Diapers valued at \$23.88.

On Thursday May 14, 2020 while McCulley was working, security called the Chesterfield Police Special Enforcement Unit reporting they had an employee who had been stealing. Officers Fenton and Bromwich responded.

McCulley was brought to the security office. There he admitted committing the thefts adding that he did it because he has EIGHT CHILDREN. I'm not sure how rose bushes relate to rearing kids. Also McCulley was divorced twice since 2016 with children and a third divorce filed in 2021 is pending.

McCulley had an arrest in 2017 for Domestic Violence, but that charge was later dropped. But he did serve 6-months in jail in 2008.

**OUTCOME**: McCulley went out and hired a Clayton lawyer for his Chesterfield theft cases. That made him eligible for the PA Engelmeyer-Judge Brunk deal where if you hire a lawyer the criminal charges disappear. In this case the two theft cases were rolled up into one Health Code Violation. McCulley pled guilty on 10/26/20 to something he did not do and was fined \$350.
