Seven times in the last 19 months Connie Fults, an elected official (Councilman City of Chesterfield)

has failed to file Quarterly Reports of Campaign and Committee activity six times for a total of 359 days.

Fults has been sent 18 warning letters from the St. Louis County Board of Elections stating she was in violation of RsMO 130.021 #4 along with plenties under Missouri Law.

Rather than compiling, Fults continued to violation the law.

I have enclosed copies of the letters from the St. Louis County BOE and documents filed in violation of Missouri Law.

The documents show:

- 1) Fults was 77 days late in filing 2nd quarter 2014 report and received 3 warning letters.
- 2) Fults was 104 days late in filing 3rd quarter 2014 report and received 3 warning letters.
- 3) Fults was 12 days late filing 4th quarter 2014 report due on Jan. 15, 2015
- 4) Fults was 49 days late filing the 1st quarter 2015 report and received two warning letters
- 5) Fults was 49 days late filing the 2nd quarter 2015 report and received three warning letters
- 6) Fults was at least 34 days late filing the 3rd quarter 2015 report and received 2 warning letters
- 7) As of Feb. 29, 2016 Fults was 44 days late in filing 4th quarter 2015 report and had received two warning letter.

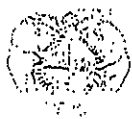
