ON THE MORING OF THE SERVICE THE SERVER NOTICED THAT THE CURTAINS WERE OPEN AND THE WINDOW WAS PARTIALLY UP ON THE WINDOW TO THE LEFT OF THE FRONT DOOR WHICH AFFORDED THE SERVER A VIEW INTO THE MASTER BEDROOM WHERE HE OBSERVED WHAT APPEARED TO BE THE SUBJECT LYING IN BED. 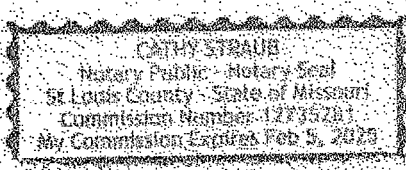
