The Grand Jurors of the County of St. Louis, State of Missouri, charge:

COUNT: 01 STATUTORY RAPE - 2ND DEGREE - CLASS D FELONY

That John Low , in violation of Section 566.034, RSMo, committed the class D felony of statutory rape in the second degree, punishable upon conviction under Sections 558.011 and 560.011, RSMo, in that on or about on or about January 23, 2022, in the County of St. Louis, State of Missouri, the defendant had sexual intercourse with Confidential Victim and at that time Confidential Victim was less than seventeen years old and the defendant was twenty-one years of age or older.

COUNT: 02 STATUTORY SODOMY - 2ND DEGREE - CLASS D FELONY

That John Low , in violation of Section 566.064, RSMo, committed the class D felony of statutory sodomy in the second degree, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that on or about on or about January 23, 2022, in the County of St. Louis, State of Missouri, the defendant had deviate sexual intercourse with Confidential Victim and at that time Confidential Victim was less than seventeen years of age and the defendant was twenty-one years of age or older.

COUNT: 03 CHILD MOLESTATION - 4TH DEGREE - CHILD LESS THAN 17 YOA AND OFFENDER GREATER THAN 4 YEARS OLDER - CLASS E FELONY

That John Low , in violation of Section 566.071, RSMo, committed the class E felony of child molestation in the fourth degree punishable upon conviction under Sections 566.071, 558.011 and 558.002, RSMo, in that on or about on or about January 23, 2022, in the County of St. Louis, State of Missouri, the defendant, being more than 4 years older than Confidential Victim knowingly subjected Confidential Victim who was less than 17 years old to sexual contact by touching the genitals of Confidential Victim.
